Note for QR/Barcode Usage and Device License

You can issue a QR/Barcode to a user and use it as an authentication method. Scan the QR/Barcode properly by following the instructions on the screen to increase the recognition rate.


How to scan a QR/Barcode

XS2-QDPB, XS2-QAPB



- Keep 5 ~ 20 cm of distance between the QR/Barcode authentication unit of the device and the QR/Barcode.
- Hold the smartphone with the screen facing towards the QR/Barcode code authentication unit and place the guide beam at the center of the QR code.
- When authenticating with the QR/Barcode downloaded to your smartphone, adjust the brightness of your smartphone so that the device can read the QR/Barcode clearly.
- If do not follow the instructions on the screen, it may take a long time to scan the QR/Barcode, or it may fail.

XS2-DPB, XS2-APB



- Keep 5 ~ 20 cm of distance between the device's camera and the QR/Barcode.
- Position the QR/Barcode in the center of the scan screen of the device.
- When authenticating with the QR/Barcode downloaded to your smartphone, adjust the brightness of your smartphone so that the device can read the QR/Barcode clearly.
- If do not follow the instructions on the screen, it may take a long time to scan the QR/Barcode, or it may fail.

Notes for Device License

- Using the QR/Barcode authentication requires a separate device license. Contact the place of purchase to issue a device license.
- The device license file is an encrypted file and cannot be modified arbitrarily.
- Device licenses are issued based on device ID. If the device ID is changed in an unusual way, the warranty service for the license is not provided.


Installation

Fixing the bracket and the product




This document describes the installation method using XS2-QDPB, XS2-QAPB models. Install XS2-DPB, XS2-APB models in the same way.


- 1 Determine the correct position to install the bracket using the provided drilling template. Fix the bracket firmly using fixing screws through the bracket to the position where X-Station 2 will be installed.



- If installing X-Station 2 on a concrete wall, drill holes, insert PVC anchors, and fix them with fixing screws.
- To avoid RF interference, a minimum separation distance must be maintained.






- When using a mobile access card, install devices maintaining a minimum distance of 1 m between devices to avoid RF interference.


- 2** Assemble the cable cover and install X-Station 2 onto the fixed bracket.



- 3** Connect X-Station 2 to the bracket by rotating the product fixing screw of X-Station 2.



Power supply connection




- Use the IEC/EN 62368-1 approved power adapter that supports higher power consumption than the product. If you wish to connect and use another device to the power supply adapter, you should use an adapter with a current capacity which is the same or larger than the total power consumption required for the terminal and another device.
 - Refer to the **Power** in the product specifications for maximum current consumption specifications.
- DO NOT extend the length of power cable when using the power adapter.
- Use a separate power supply for Secure I/O 2, the electric lock, and the product respectively. If connecting and using the power supply to these devices together, the devices may malfunction.
- DO NOT connect the device to the DC power supply (or adapter) and PoE power supply at the same time.



You can connect the product to a hub using a general type CAT-5 cable.




LAN connection (connecting to a PC directly)

X-Station 2 has an automatic MDI/MDIX function so that it can be connected to a PC directly using a normal straight type CAT-5 cable or a cross cable.





Relay connection

Fail Safe Lock

In order to use the Fail Safe Lock, connect N/C relay as shown in the figure below. There is normally a current flowing through the relay for the Fail Safe Lock. When the relay is activated, blocking the current flow, the door will open. If the power supply to the product is cut off due to a power failure or an external factor, the door will open.




- Install a diode at both sides of the door lock wire as shown in the figure to protect the relay from the reverse current, which occurs when the door lock operates.
- Use a separate power supply for X-Station 2 and the door lock.
- Suprema's standalone intelligent readers contain internal relays that can directly lock/unlock doors without external controllers for added convenience. For access control applications in need of security, however, it is NOT recommended to use the internal relay of a reader to prevent any tampering attacks which can potentially trigger the door unlock. For such applications, it is highly recommended to use a separate relay unit for a lock control such as Suprema's Secure I/O 2, DM-20 or CoreStation installed at a secure side of a door.

Fail Secure Lock

In order to use the Fail Secure Lock, connect N/O relay as shown in the figure below. There is normally no current flowing through the relay for the Fail Secure Lock. When the current flow is activated by the relay, the door will open. If the power supply to the product is cut off due to a power failure or an external factor, the door will lock.




- Install a diode at both sides of the door lock wire as shown in the figure to protect the relay from the reverse current, which occurs when the door lock operates.
- Use a separate power supply for X-Station 2 and the door lock.
- Suprema's standalone intelligent readers contain internal relays that can directly lock/unlock doors without external controllers for added convenience. For access control applications in need of security, however, it is NOT recommended to use the internal relay of a reader to prevent any tampering attacks which can potentially trigger the door unlock. 

Connecting as a standalone

X-Station 2 can be connected to the door lock, door button, and door sensor directly without connecting a separate I/O device.



Connecting to Secure I/O 2

Secure I/O 2 is an I/O device, can be connected to X-Station 2 with the RS-485 cable. Security can be maintained even if the connection between X-Station 2 and Secure I/O 2 has been lost or the power supply to X-Station 2 has been shut off due to external factors.


- Use an AWG24 twisted pair with a maximum length of 1.2 km for the RS-485 cable.
- If connecting with a RS-485 daisy chain, connect the termination resistor (120 Ω) to both ends of the daisy chain connection. If connected to the middle line, the signal level becomes smaller and the communication performance will deteriorate. Make sure to connect it to both ends of the daisy chain connection.



- X-Station 2 can be used as a multi-door controller with the slave devices with the RS485 cable. The slave devices are used as dummy readers and authentication is performed in the master device.





Some devices are designed to deny users access to install or run modified versions of the software inside them, although the manufacturer can do so. This is fundamentally incompatible with the aim of protecting users' freedom to change the software. The systematic pattern of such abuse occurs in the area of products for individuals to use, which is precisely where it is most unacceptable. Therefore, we have designed this version of the GPL to prohibit the practice for those products. If such problems arise substantially in other domains, we stand ready to extend this provision to those domains in future versions of the GPL, as needed to protect the freedom of users.

Finally, every program is threatened constantly by software patents. States should not allow patents to restrict development and use of software on general-purpose computers, but in those that do, we wish to avoid the special danger that patents applied to a free program could make it effectively proprietary. To prevent this, the GPL assures that patents cannot be used to render the program non-free.

The precise terms and conditions for copying, distribution and modification follow.

TERMS AND CONDITIONS

0. Definitions.

"This License" refers to version 3 of the GNU General Public License.

"Copyright" also means copyright-like laws that apply to other kinds of works, such as semiconductor masks.

"The Program" refers to any copyrightable work licensed under this License. Each licensee is addressed as "you".

"Licensees" and "recipients" may be individuals or organizations.
