正しい顔の登録と認証方法

顔の登録時の注意点

- 顔を登録する際は、デバイスと顔の距離を 60 cm から 100 cm の間で維持します。
- 顔の表情を変えないように注意してください。
- 目や眉が隠れないように注意してください。
- マスクや眼鏡は着用しないでください。
- 画面に二人の顔が映らないように注意してください。一度に一人の顔を登録してください。
- 画面の指示に従わない場合、顔の登録に時間がかかったり、失敗したりする可能性があります。

顔認証時の注意点

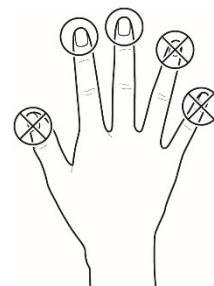
- デバイスの画面の中央に顔が表示されていることを確認します。ガイドラインが表示されたら、画面に表示される指示に従って顔認証を行います。
- 顔の一部がマスクやサングラスで隠れている場合は、認証が失敗することがあります。顔を覆わないでください。デバイスが眉と顔の両方を認識できるようにしてください。

指紋を登録する方法

指紋の認証率を上げるために、指紋を正しく登録してください。FaceStation F2 では、ユーザーの指紋入力角度と位置が変化しても指紋を認識できます。指紋を登録する際に次の点に注意すると、認証率が上がる場合があります。

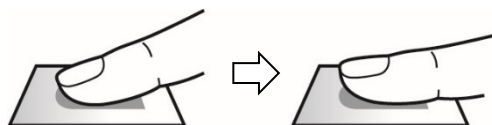
指紋を入力する指を選ぶ

- 特定の指の指紋を使用できない場合、例えば片手で荷物を持ち上げていたり、指に怪我をしていたりする場合に備えて、ユーザーごとに最大 10 個の指紋を登録できます。
- 指紋がうまく認識されない場合は、2 回連続して同じ指で登録すると認証率が上がる場合があります。
- 指に切り傷がある場合や、指紋がはっきりしない場合は、別の指の指紋を登録します。
- 指紋をスキャンする際に人差し指または中指を使用することを推奨します。指紋センサーの中央に別の指を正確に置くことが難しい場合は、認証率が低下する場合があります。



指紋の登録方法

- 1 「センサーに指を置いてください」というメッセージが指紋の登録用の LCD 画面に表示されたら、指紋を登録する指を指紋認証ユニットに置き、認証率を上げるために指を軽く押し付けます。



- 2 ビープ音の後に再入力画面が表示されたら、登録した指の指紋を再度スキャンします（登録する指の指紋を 2 回スキャンします）。

注意

指紋の登録に関する注意

指紋認識時には最初に登録した指紋と照合されるため、最初の指紋登録が最も重要です。指紋を登録する際は次の点に注意してください。

- 指をセンサーに密着させてしっかりと押し付けます。
- 指紋の中央をセンサーの中央に合わせてください。
- 指に切り傷がある場合や、指紋がはっきりしない場合は、別の指の指紋を登録します。
- 画面の指示に従って、指を動かさずに指紋を正しくスキャンします。
- 指を動かしてセンサーとの接触面が小さくなったり指の角度が変わったりすると、指紋認証が行われない場合があります。



指紋認識が失敗した場合

FaceStation F2 は、季節の変化や指の状態にかかわらず、指紋を認識できます。ただし、認証率は、外部環境や指紋入力方法によって異なる場合があります。

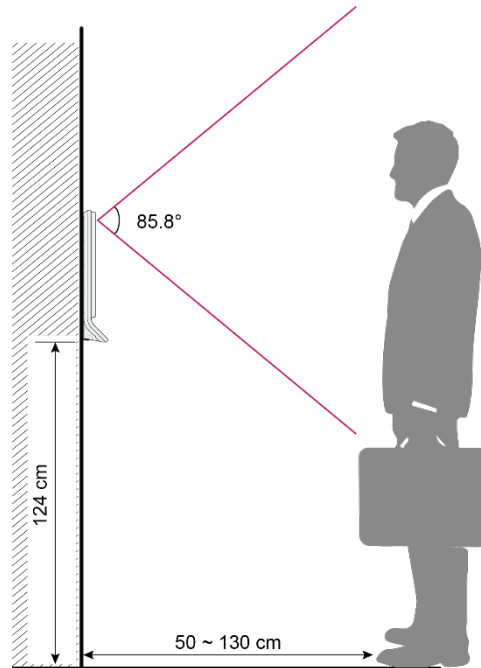
指紋認証がスムーズにいかない場合は、以下の措置を講じることをお勧めします。

- 指が水や汗で濡れている場合は、指を乾かしてからスキャンします。
- 指が乾燥し過ぎている場合は、指先に息を当ててから指をスキャンします。
- 指を切った場合は、別の指の指紋を登録します。
- 最初に登録した指紋が正しくスキャンされていない場合があるため、「指紋の登録に関する注意」に従って、もう一度指紋を登録してください。

設置場所

ブラケットと製品の固定

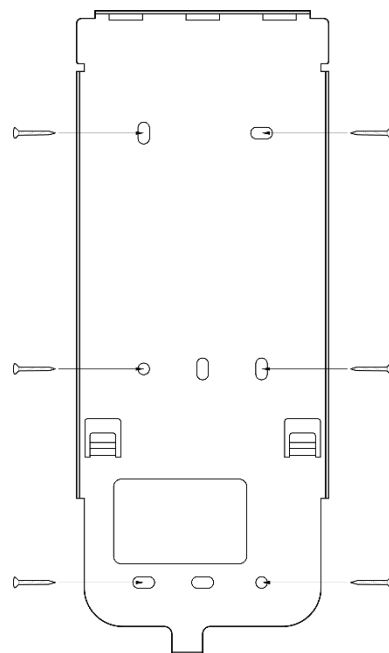
- 1 付属のドリル用テンプレートを使用して、製品を取り付ける正しい位置を決定します。



注意

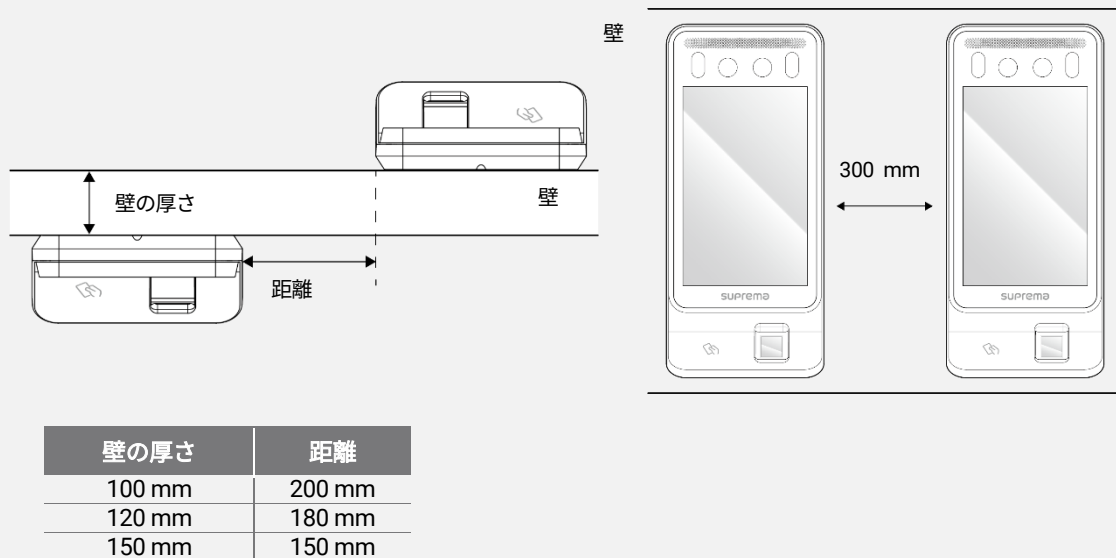
- デバイスを設置する際の最適な高さは 124 cm です。
- デバイスは直射日光や紫外線が当たらない場所に設置してください。
- ユーザーが認証しようとしたときに顔が直射日光にさらされないように、設置位置を調整します。

- 2 固定ねじをブラケットに通して、FaceStation F2 の取り付け位置にブラケットをしっかりと固定します。



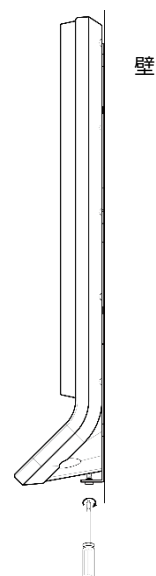

- コンクリート壁に FaceStation F2 を設置する場合は、ドリルで穴を開け、PVC アンカーを挿入して、固定ねじで固定します。
- RF 干渉を回避するには、最小分離距離を維持する必要があります。

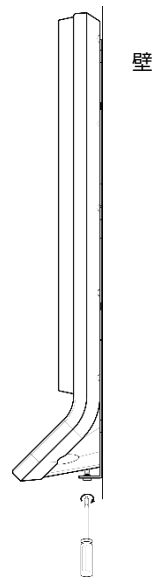

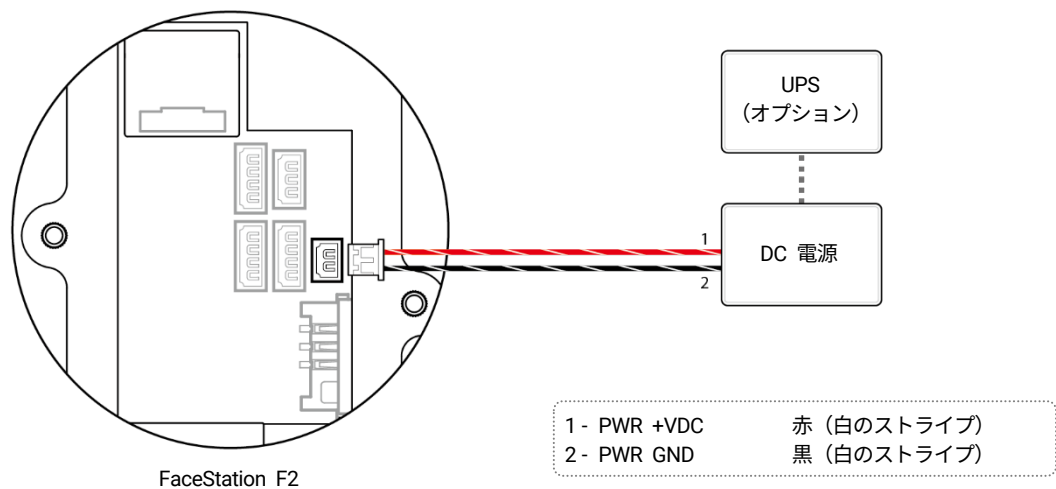

電源装置の接続



注意

- IEC/EN 60950-1 の認可を受けた 2,500 mA 以上の DC 24 V または DC 12 V (± 10 %) の電源アダプタを使用します。別のデバイスを電源アダプタに接続して使用する場合は、端末と別のデバイスに必要な合計の電力消費量以上の電流容量を備えたアダプタを使用してください。
- Secure I/O 2、電子ロック、および製品ごとに独立した電源を使用してください。これらのデバイスを同じ電源に接続して使用すると、デバイスが正常に機能しない場合があります。
- 電源装置を接続するときは、FaceStation F2 と電源装置の距離に注意してください。FaceStation F2 は、接続ケーブルの長さを最短に保つために、電源装置にできるだけ近い位置で接続する必要があります。ケーブルが正しく接続されていないと、デバイスが誤動作を起こす恐れがあります。FaceStation F2 が電源から離れている場合は、16 AWG または 18 AWG ケーブルを使用することをお勧めします。接続距離は、使用するケーブルの規格と設置環境によって異なる場合があります。FaceStation F2 は DC 24 V と DC 12 V の両方の電源をサポートしているため、ケーブルの仕様に従って最大長を確認し、ユニットに適切に電力が供給されるようにします。

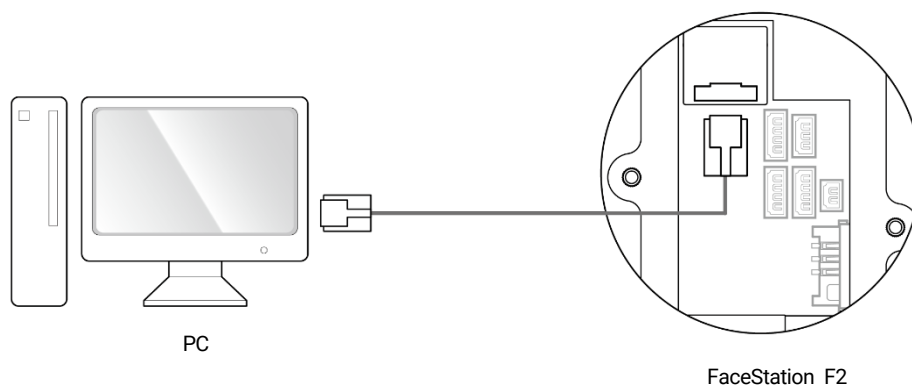

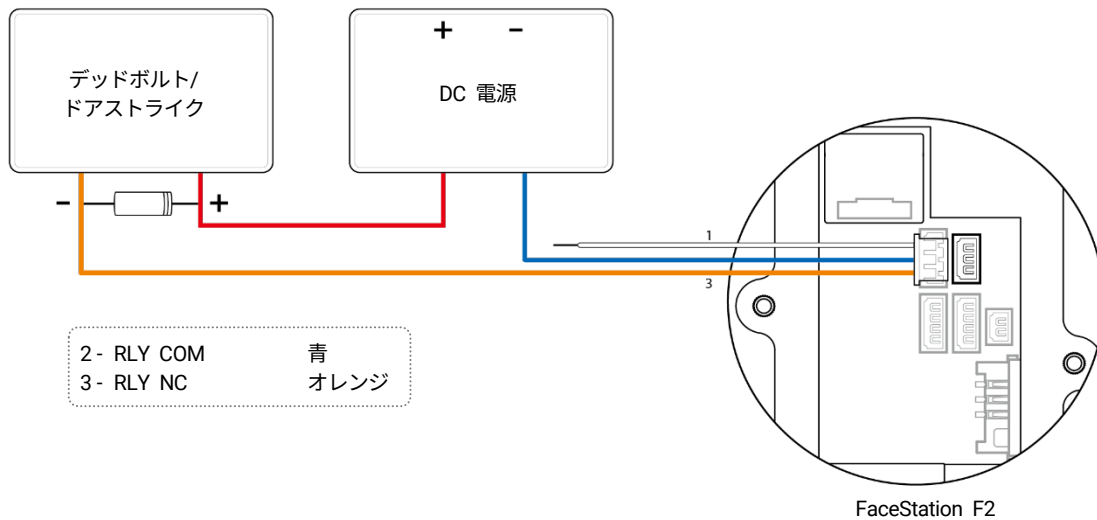

フェールセーフロック

フェールセーフロックを使用するために、下の図のように N/C リレーを接続します。通常、フェールセーフロック用のリレーには電流が流れています。リレーが作動して電流が遮断されると、ドアが開きます。停電や外部の要因のために製品に接続した電源が切断された場合は、ドアが開きます。

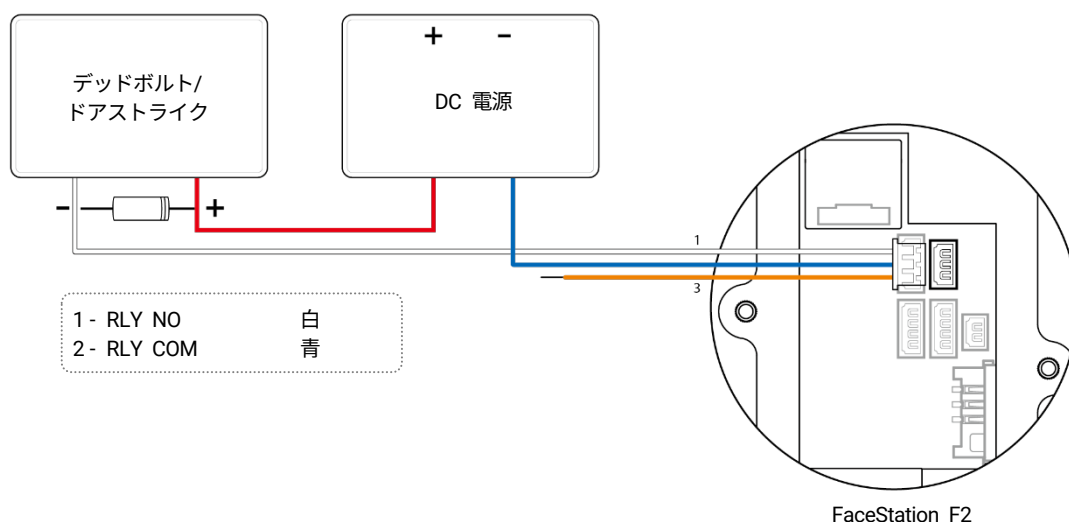

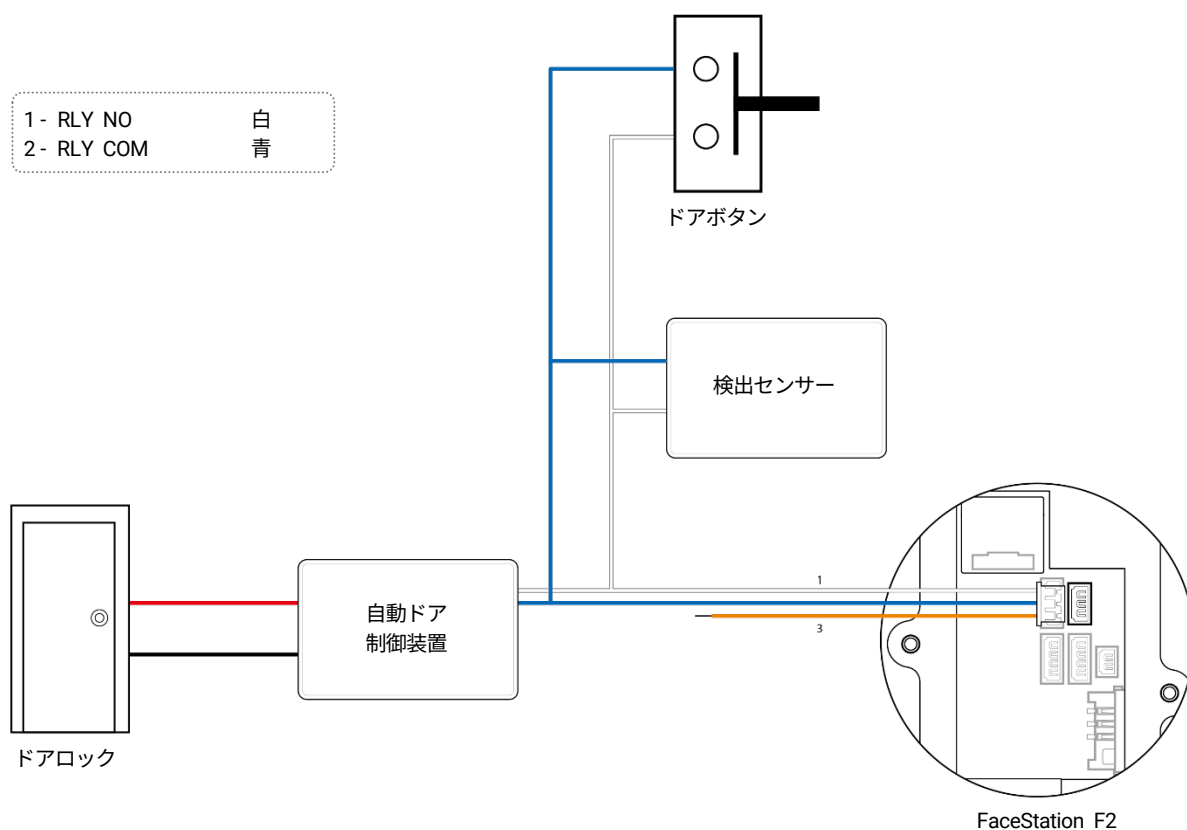

Secure I/O 2 への接続

Secure I/O 2 は、RS-485 ケーブルで FaceStation F2 に接続できる I/O デバイスです。FaceStation F2 と Secure I/O 2 の間の接続が失われたり、外部要因により FaceStation F2 への電源が切断されたりしても、セキュリティを維持できます。

- RS-485 ケーブルには、最大長が 1.2 km の AWG 24 ツイストペアを使用します。
- RS-485 のデジチェーンで接続する場合は、デジチェーン接続の両端に終端抵抗（120 Ω）を接続してください。中央の線に接続すると、信号レベルが小さくなり、通信性能が低下します。必ずデジチェーン接続の両端に接続してください。

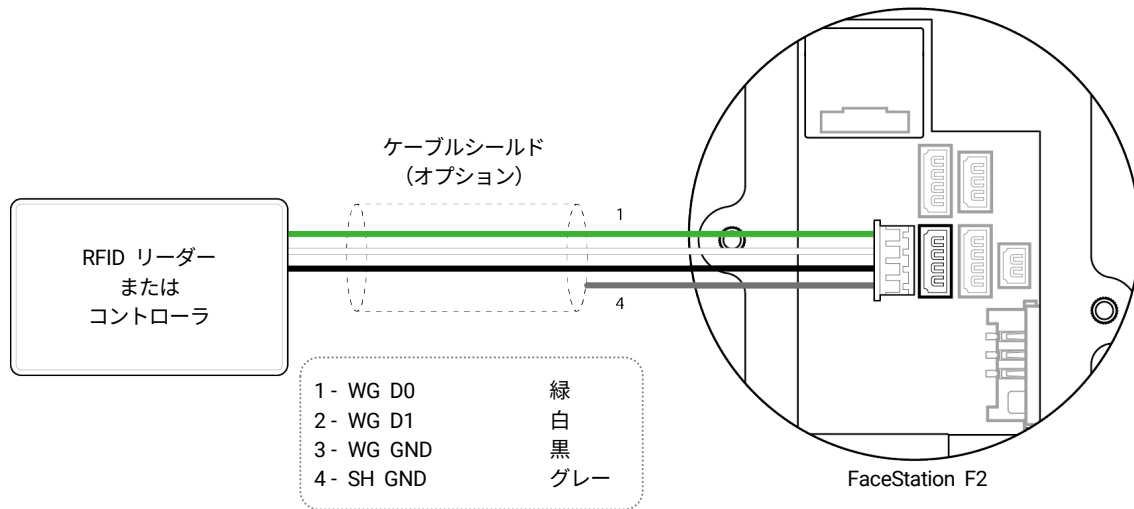

Preamble
