## 올바른 얼굴 등록 및 인증 방법

### 얼굴 등록 시 주의 사항

- 얼굴을 등록할 때 장치와 얼굴의 거리를 60 ~ 100 cm로 유지하십시오.
- 표정이 변하지 않도록 주의하십시오.
- 마스크, 모자, 안대를 착용하지 마십시오.

- 눈을 감지 마십시오.

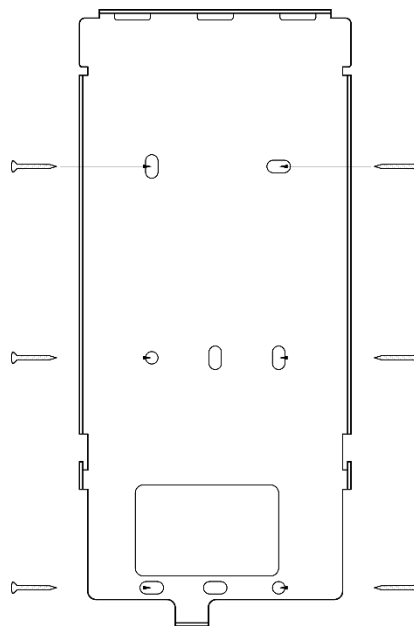

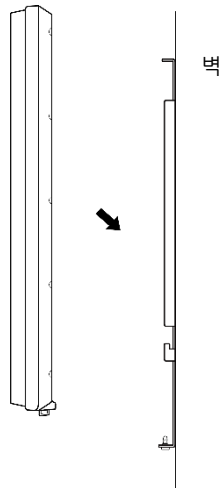

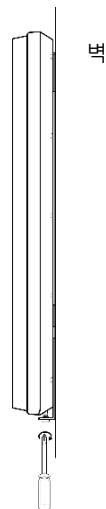

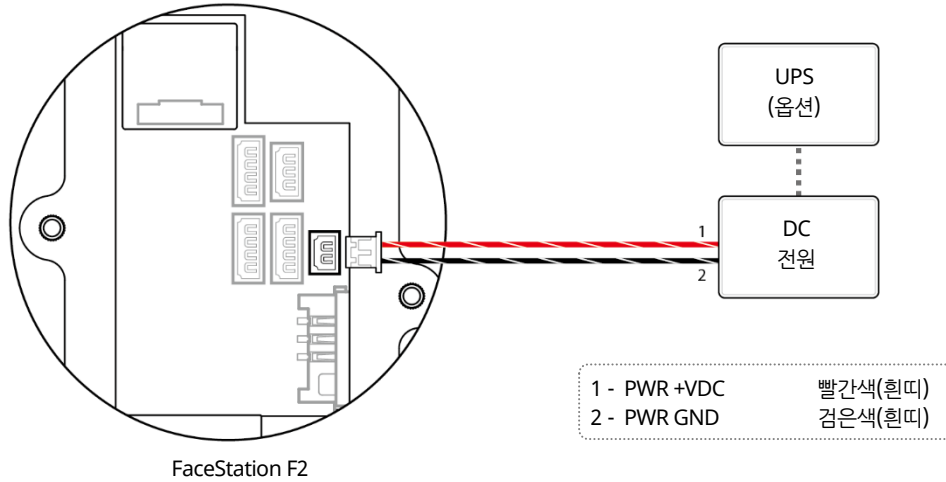

## 전원 연결



### 알아두기

### Fail Safe Lock

## Secure I/O 2 연결

FaceStation F2에 I/O 장치인 Secure I/O 2를 RS-485로 연결할 수 있습니다. FaceStation F2와 Secure I/O 2의 연결이 끊기거나 외부 요인에 의해 FaceStation F2의 전원이 차단되더라도 보안을 유지할 수 있습니다.

- RS-485 케이블은 AWG24, 꼬임선(Twisted Pair), 최대 길이 1.2 km를 사용하십시오.
- RS-485 데이터 체인으로 연결할 경우 종단 저항(120Ω)을 데이터 체인 연결의 양 끝에 연결하십시오. 중간 선로에 연결할 경우 신호 레벨이 작아져 통신 성능이 떨어지므로 반드시 데이터 체인 연결의 양 끝에 연결하십시오.

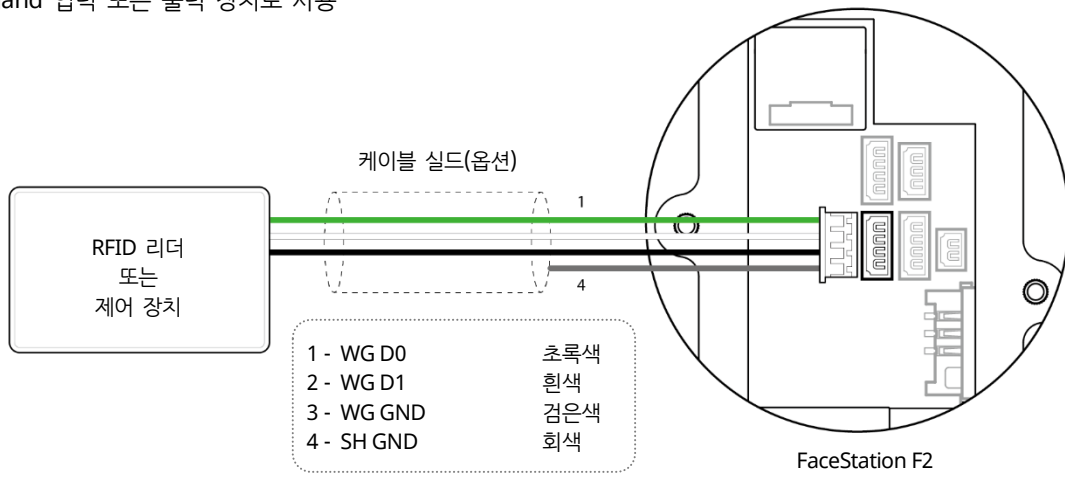
